Team Talk Advent Calendar Terms and Conditions

- By submitting an entry to the Team Talk Advent Calendar Prize Draw Prize Draw (the "Prize Draw") you confirm your acceptance of these Terms and Conditions and the use of your name, role, image and likeness in conjunction with the Prize Draw and in particular the publication of any list of names and publicity for the winner as explained further in these Terms and Conditions.
- 2. This Prize Draw is promoted and managed by Jaguar Land Rover Limited registered in England and Wales, registered office: Abbey Road, Whitley, Coventry, CV34 4LF, company number 1672070 (the "**Promoter**").
- 3. These Terms and Conditions apply so far as the law permits so please read them carefully before entering.

Can I enter the Prize Draw?

- 4. Entry into the Prize Draw is free.
- 5. The Prize Draw is open to all Jaguar Land Rover and Manpower Employees aged 18 or above and working in the UK at the time of entry. Proof of age will be required from the winner.
- 6. Eligible entrants must also hold a full, current and valid UK driver's licence. The entrant must have held their driving licence for a minimum of 12 months and have no more than 6 penalty points against their licence at the time of entry to the Prize Draw. A copy of the winner's driving licence may be requested by the Promoter.
- 7. Any employee of the Promoter involved with the Prize Draw will not be eligible to enter this Prize Draw.

How to enter

- 8. The Prize Draw is open from midnight 4th December 2017 and will close at midnight 31st December 2017 (the "**Prize Draw Period**"). Any entries received after this time will not be considered valid and will not be entered into the Prize Draw.
- 9. To enter the Prize Draw you will require internet access and to download the TeamTalk app ("App") from www.teamtalk.jaguarlandrover.com (the "Website").
- 10. On the Website or the mobile iOS or Android App, you must find and save 12 TeamTalk Advent Calendar Windows to your electronic device. The 'Windows' will appear on the TeamTalk website as a text link at the bottom of various pages and news articles. If you haven't already downloaded the app, you must then either register your email address using the email input form on the homepage of http://www.teamtalk.jaguarlandrover.com. The Promoter will send you a link to download the App (push notifications must be turned on, on your device when prompted). The Promoter will then send you, via push notification, the email address to send your 12 collected advent numbers. Attach all 12 collected window images to an email and send it to the address given, along with your name.
- 11. Only entries received during the course of the Prize Draw Period and in accordance with these Terms and Conditions will be eligible for entry into the Prize Draw.
- 12. Only one entry per person is permitted for the Prize Draw. Multiple entries will be ineligible. Anyone found to have used multiple accounts to enter the Prize Draw will be ineligible.
- 13. If, for any reason, a technical interruption, fault, App or site failure occurs, the Promoter does not take any responsibility for inability to enter or for incomplete or late entries and any such entries will not be considered valid.

The Prize

- 14. The prize is available to six winners and one nominated quest per winner. The prize will be:
 - A half day track experience at one of Jaguar Land Rover's centres one of a number of locations which will be offered to the winning entrant and it will be for the winning entrant to choose the most suitable location.
 - The track day will take place on a date from one of a number of dates offered to the winning entrants and it will be for the winning entrants to choose the most suitable date.

(the "Prize")

- 15. The Promoter is not responsible for any additional costs and/or expenses in relation to the Prize (without limitation) including travel costs, other than any specifically listed as part of the Prize above and for the specified periods of time (where applicable).
- 16. Entrants may only win one Prize throughout the duration of the Prize Draw.
- 17. Each valid entry received within the Prize Draw Period will be allocated a number. These numbers will then be placed into a random number generator on 3rd January 2017 and six numbers will be drawn at random to determine the winning entrants. This process will be observed and verified by an independent observer. The selection process is final and therefore no correspondence will be entered into thereafter.
- 18. The winning entrant will be contacted via email or telephone within 5 working days of the Prize Draw Period ending. The Promoter will use the contact details supplied with the entry to contact the winner and will not be responsible if the contact details supplied to it are incorrect. Please ensure that the email address you provide is valid in order for the Promoter to contact you once you have won.
- 19. The winning entrant will be asked to confirm their name and postal address, that they accept the Prize and which Jaguar Land Rover Centre they wish to have their experience at and when, by replying to the Promoter. If the winning entrant cannot be contacted within 5 working days after the first attempt to contact them, then the Promoter reserves the right (at its absolute discretion) to offer that Prize to another entrant who will be selected at random. No alternative prize will be awarded to the original winning entrant.
- 20. If the Prize is not claimed by the winning entrant, for any reason, it will be forfeited. The Promoter reserves the right (at its absolute discretion) to pick an alternative winning entrant if the Prize is not claimed by this deadline and this alternative winning entrant will be selected at random. No alternative prize will be awarded to the original winning entrant.
- 21. Once the winning entrant has confirmed they accept the Prize, they will be asked to confirm their chosen date and location to take up the Prize.
- 22. If the Promoter subsequently discovers the winning entrant is ineligible, has breached these Terms and Conditions or the App rules or is suspected of engaging in any other foul play or unethical conduct then the Promoter reserves the right (at its absolute discretion) not to award the Prize to that entrant and award the prize to another entrant will be selected at random. In that event the original winning entrant agrees to return the Prize (at his/her expense) immediately to the Promoter. No alternative prize will be awarded to the original winning entrant.
- 23. If the Prize offered is unavailable, cancelled or suspended due to circumstances beyond the control of the Promoter, the Promoter has the right, but is not obliged, to offer an alternative prize of equal or greater value to the face value of the Prize. The winning entrant will not be

- entitled to any monetary equivalent or compensation for any costs or expenses incurred or suffered in connection with taking up the Prize.
- 24. There is no cash or credit alternative and the Prize is non-transferable, non-negotiable and is not for resale.
- 25. In all circumstances, the Promoter's decision is final and no correspondence will be entered into.

Liabilities

- 26. Neither the Promoter, nor its respective group companies, nor its affiliates, agents, officers or employees will be liable (to the extent permitted by law) for any loss or damage arising out of organising or holding this Prize Draw or as a result of an entrant's participation in it, participation in any activities or as a result of the winning entrant winning, collecting, using or enjoying the Prize, or if the Prize Draw does not run as planned. This clause does not seek to exclude the liability of the Promoter, any related third party and its respective group companies for (a) death or personal injury caused by its negligence, (b) fraud or fraudulent misrepresentation, and/or (c) any other matter for which it would be unlawful for it to exclude or attempt to exclude its liability.
- 27. The Promoter may change these Terms and Conditions or cancel the Prize Draw at its absolute discretion and without incurring liability as a result unless the Prize has been awarded.
- 28. These Terms and Conditions and any disputes arising therefrom shall be governed and construed in accordance with English law. The parties agree that the courts of England and Wales shall have exclusive jurisdiction to deal with any dispute or claim that arises out of or in connection with these Terms and Conditions and the Prize Draw including non-contractual claims.
